

## Content License Agreement

This agreement is made by Power to Change Ministries, through its division TruthMedia ("Publishing Producer"), with \_\_\_\_\_ ("Performing Author") concerning the creative works \_\_\_\_\_ ("Short Film"), which will be remitted by Performing Author to Publishing Producer no later than \_\_\_\_\_ (month/day/year).

Whereas Performing Author and Publishing Producer mutually desire to have Short Film produced and published/republished by Publishing Producer, and in consideration of the expenses incurred by Publishing Producer to produce Short Film; Performing Author's voluntary involvement with Publishing Producer; and both parties' interest in furthering the Gospel through the use of multimedia ministry, the parties agree on the following items:

1. Performing Author and Publishing Producer both desire to further the Gospel of Christ through the use of multimedia ministry opportunities, in methods consistent with the Christian faith and biblical standards of practice.
2. Performing Author created and developed the content of Short Film, and is the owner of that content.
3. Both parties agree that while Performing Author owns the content of Short Film, Publishing Producer owns the produced and published Short Film themselves, and that as such, the parties desire to clarify right for usage of Short Film as a jointly created work.
4. Performing Author agrees to perform Short Film, to be filmed, produced and published by Publishing Producer, without remuneration.
5. Publishing Producer agrees to incur the costs for the filming, editing, producing, and publishing of Short Film in consideration of Performing Author granting a multiple use permission to Publishing Producer for Short Film.
6. Performing Author grants, in perpetuity, a multiple use permission for Publishing Producer to use the described Short Film in varying formats, editions, adaptations and foreign-language translations, in video, text or other forms of media, on or by, any and all publication, websites, and other delivery formats, which are part of the ministry/business of Producing Publisher and/or with whom Producing Publisher has a valid content syndication agreement.
7. The Performing Author and Publishing Producer agree that, further to Articles 6, Publishing Producer's permission for use will be restricted to use of the Short Film in an independent format, or to further truncated formats.
8. Each party grants to the other, within the formats delineated by Article 7, an unlimited multiple-use permission of Short Film, where they are used without compensation and under the terms of this agreement.
9. Further to Article 6, if or when either party sells or distributes Short Film in a format for sale, that party will remit to the other 15% ("Royalty") of the net profits of that sale; where "net profits" are defined as gross profits less reasonable administrative cost, which are not to exceed 30%; plus distribution costs. Payment to the other party shall be made by the last day of June and December of each calendar year.
10. Further to Article 9, Performing Author is not required to remit to Publishing Producer Royalty until he has fully recouped the production costs relating to production of Short Film.
11. Performing Author grants that Producing Publisher does not require further pre-publication approval for any edits, adaptations, translations or republishing of Short Film; and Producing Publisher grants that Performing Author does not require further pre-publication approval for any edits, adaptations, translations or republishing of Short Film.
12. Performing Author attests to being the author and creator of the content of Short Film; being either the copyright owner or the legally authorized agent of copyright owner of Short Film; and being legally able to grant and assign such rights, and that Short Film do not infringe any copyright or proprietary right of any other person.

13. Publishing Producer and Performing Author agree that this agreement is only an agreement regarding the use of Short Film, and does not assign or transfer copyright or any other rights.
14. Publishing Producer agrees to include with the Short Film the copyright information for the content of Short Film, as designated by Performing Author at time of agreement.
15. Publishing Producer and Performing Author agree that this agreement shall be governed by the laws of British Columbia, Canada, and that resolution of any apparently irreconcilable difference will be via arbitration.
