NOW THEREFORE THIS AGREEMENT WITNESSES THAT in consideration of the mutual spirit and other covenants and agreements herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by both parties, PTC and Author agree as follows:

C. PTC wishes to produce and publish multimedia ministry materials, based on Script, and Author has accepted PTC's offer.

- 1. Author created and developed Script, and is the owner of said Script.
- 2. PTC is the Publisher and Producer of multimedia ministry materials ("Materials"); including videos, websites, and ministry materials of varying delivery formats, and is the owner of said Materials.
- Author grants, in perpetuity, a multiple use permission for PTC to use the described Script in varying formats, editions, adaptations and foreign-language translations, in video, text or other forms of media, on or by, any and all publication, websites, and other delivery formats of Materials, which are part of the ministry of Producing Publisher and/or with whom Producing Publisher has a valid content syndication agreement.
- 4. PTC agrees to include with the Script the copyright information for Script, as designated by Author at time of the Agreement.
- 5. In consideration of Articles 3 and 4, the parties grant to each other, an unlimited multiple-use permission of Script without additional compensation and under the terms of the Agreement.
- 6. Author grants that Producing Publisher does not require further pre-publication approval for any edits, adaptations, translations or republishing of Script; and Producing Publisher grants that Author does not require further pre-publication approval for any edits, adaptations, translations or republishing of Script.
- 7. Author attests to being the originator and creator of the content of Script; being either the copyright owner or the legally authorized agent of the copyright owner of Script; and being legally able to grant and assign such rights, and that Script do not infringe any copyright or proprietary right of any other person.
- 8. PTC and Author agree that this Agreement is only an agreement regarding the use of Script, and does not assign or transfer copyright or any other rights.

- 9. PTC and Author agree that this agreement shall be governed by the laws of British Columbia, Canada.
- 10. The parties agree that any claim or dispute arising out of, or related to, this Agreement or to any other aspect of the relationship between the parties, shall be settled by biblically-based mediation in accordance with the "Rule of Procedure for Christian Conciliation" contained in the Peacemaker Ministries booklet, <u>Guidelines for Christian Conciliation</u>. If resolution of the dispute and reconciliation do not result from mediation, then the matter shall be submitted to an independent and objective arbitrator for binding arbitration. The arbitrator shall have Christian values and the arbitration shall be conducted in accordance with the commercial arbitration legislation which governs the province of British Columbia, Canada.
- 11. If any provision of this Agreement is determined to be invalid, void or unenforceable, in whole or in part, such validity, voidance or unenforceability shall attach only to such provision or part thereof, and the remaining part of such provision and all other provisions thereof shall continue in full force and effect.
- 12. This Agreement contains the complete agreement concerning Script and shall, as of the date it is executed, supersede any and all other agreements made between the parties. No waiver or modification of this Agreement or any covenant, condition or restriction herein contained shall be valid unless executed in writing by the party to be charged herewith.
